**ENTRIES:** The Entry Fee for this Event will be \$30 for holders of an existing CAMS licence. An L1 Come and Try Licence can be purchased on the day for an additional \$20 (total entry costs for those without an existing CAMS licence will come to \$50). The Organiser reserves the right to refuse entry in accordance with NCR 83 of the current CAMS Manual. **Children 12 years old to 18 years** can drive on a come and try licence for just \$25.

Entries open on publication of these regulations and close after 1:00pm on the day of the Event. The maximum number of entries for this Event will be 40. Up to FOUR drivers may compete in the same vehicle provided this is nominated on the Entry Form. Entries will be decided upon on order of receipt and eligibility.

**NOTE:** Drivers need a minimum Level 2 licence - Non Speed (L2NS) or Level 1 Come and Try Licence (which can be purchased on the day). Instructors will have a minimum L2NS licence.

**9 DRIVERS BRIEFING:** Drivers Briefings will be given for Drivers before any Driver can commence track activity - this briefing will commence at the completion of the cars scrutineering.

#### 10 VEHICLES:

- a. All vehicles must comply with Schedule A and Group 4H of the current CAMS Manual.
- b. <u>All</u> vehicles will undergo a safety check by CAMS Scrutineers prior to participation with an emphasis on brakes and seatbelts. Cars must also be free of loose items
- C. Vehicles must be adequately muffled to comply with noise restrictions
- d. Only road tyres will be allowed. Winter tread, hand-cut or Rally-type tyres of any sort will NOT be permitted.
- **e.** Fuel must comply with Schedule G of the current CAMS Manual.
- f. The Clerk of the Course will have the final say on whether or not a vehicle is deemed eligible to participate.
- g. Per Schedule D Apparel, adequate footwear must be worn by all drivers and passengers whilst competing—bare feet, thongs or sandals are not permitted; where no windscreen is fitted to a vehicle, drivers and passengers must wear adequate eye protection whilst competing
- h. All passengers, including those who have signed an Entry Form, must sign the appropriate Passenger in Vehicle Indemnity Form.

#### 10. PASSENGERS AS INSTRUCTORS ONLY

This Event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the CAMS MSPRA Policy. Passengers are only allowed where their role is as an 'Instructor'.

- (a) A Briefing must be attended by each Driver and Passenger (and guardians of each Passenger if Passenger is under 18 years of age) conducted by the Clerk of the Course prior to the MSPRA commencing.
- (b) Instructors must:
  - i. Be experienced and have the permission of the Clerk of Course. The suitability of the Passenger is at the discretion of the Clerk of Course.
  - ii. Wear the same protective gear as a Driver in accordance with Schedule D of the current CAMS Manual of Motor Sport.
  - iii. Be fitted and restrained as required for each Automobile with consideration for their physical attributes.
  - iv. Complete a Passenger Ride Entry Form and disclaimer.
  - v. Drivers must fill out a Passenger Ride Entry Form to ride as a Passenger.
- (c) Vehicles and Apparel used must pass Scrutiny.
- (d) Vehicles shall only carry one Passenger at a time, unless otherwise approved by CAMS.
- 11 **EXCLUSION:** Individuals behaving in a manner deemed to be inappropriate or prejudicial to the sport by the Clerk of the Course will be excluded from the Event.
- **12 ABANDONMENT:** The Organiser reserves the right to postpone, abandon or cancel the Event in accordance with NCR 59 of the current CAMS Manual.
- 13 **INSURANCE:** Insurance for this Event will be provided in accordance with Appendix I of the current CAMS Manual. Public Risk Insurance is covered by the Permit, and Personal Accident Insurance is incorporated into the Licence fee.
- 14 PROTESTS: Any protests must be lodged in accordance with Part XII of the current CAMS Manual.
- ALCOHOL, DRUGS AND OTHER SUBSTANCES: Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.
